#### INFORMATION REGARDING PERSONAL DATA PROTECTION

The Lisbon City Council is the controller, through Divisão da Rede de Bibliotecas, with the following e-mail and address: blx@cm-lisboa.pt and Rua da Boavista, 9, 1200-066 Lisboa.

The data will only be accessed by Lisbon City Council to accomplish the mentioned purposes, and will not be used to automated decision-making, including profiling. There will be no transfer of data to a third country or international organization.

The processing of personal data is exclusive to the procedure of requested consulting and investigation services, in which is included the respective accounting, delivery of the requested assignment and/or communications to specific clarifications, using the contacts given by the data subject, within the exercise of public interest invested by the controller – Article 6 (1), point (e), according with article 92 of Estrutura Flexível da Orgânica dos Serviços Municipais (DR, second series, number 169, September 3th, 2018) The personal data collected are the ones that are strictly necessary for the procedure of the requested consulting and investigation services, in which the accounting data are communicated to the Tax Authority electronically, in compliance with the tax legislation. The provision of personal data by the data subject is mandatory and the consequence of not providing is that the request will not be processed.

The form will be stored for a period of five years from the conclusion of the procedure, according with the article 27 of Portuguese Decree law number 433/82 and article 40 of Portuguese Law number 50/2006. After that period, the form will be eliminated.

Data subjects have the right to legal action through the competent courts and compensation if their rights are violated.
